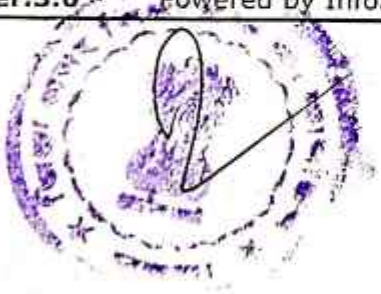

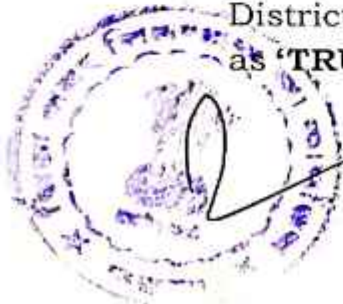

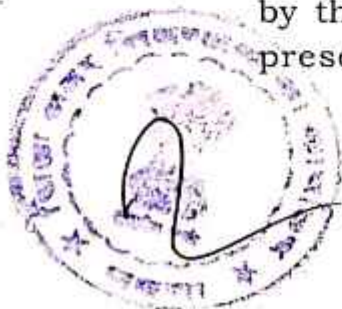

**Now this indenture witnesseth as follows :**

1. That, in order to effectuate his aforesaid desire, the founder has set apart and handed over to the trustee, a sum of Rs. 50,000/- (Rupees Fifty thousand only) (hereinafter called the 'Trust Fund' which expression shall include cash and any other property or investments of any kind whatsoever into which the same or any part thereof might be converted, invested or varied from time to time or which may be acquired by the trustee(s) or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents), and the trustee(s) shall hold and stand possessed of the same upon the trust subject to the powers, provisions, agreement and declarations hereinafter contained.

2. That the **Name** of the trust shall be **Mangalam Educational & Charitable Trust** and its office shall, for the present, situated at Behind M.I.G. 185, Hanuman Nagar, P.O.-Lohiya Nagar, P.S.- Patrakarnagar, Kankarbagh, District- Patna, Bihar, and/or at such other place or places as the trustee(s) may decide from time to time.

3. That the **objects** for which this trust is established are :

advancement of education and diffusion of knowledge amongst the public in general.

(b) To start, establish, run, take over or manage and maintain schools/colleges, IIT/ITC with an object to provide sound pre-primary, primary, middle, secondary, senior secondary and higher education/ Medical Education/Para Medical Education/Tecnicial Education to children by seeking recognition. To work for Envirment conservation, AIDS control and Construction of Road, Bridge, Building, etc.

(c) To establish and maintain a boarding house for the students who receive education in the school/college.

(d) To establish, develop, maintain and grant aid in cash to hospitals, medical schools, medical colleges, nursing institutions, dispensaries, maternity homes, child welfare centres and/or such other similar charitable institutions in India for the benefit and use of the general public.

(e) To arrange and manage the training institutions in Typing, Short Hand, Computer, Fine Arts, Crafts, Music, Dancing, Painting, Modelling, Yoga, Physical Education and in other professional training subjects.

(f) To provide food, cloths, medical aid, stationery, transportation, libraries, laboratories, reading rooms, hostels, play grounds, swimming pool and other possible facilities to the students and also to the staff of the school/college.

(g) To engage, employ or hire appropriate staff, workers, legal experts and other professionals, managers and agents for the work and furtherance of the aims and objects of the Trust and to pay their wages, salaries, stipends

(h) To promote literacy, cultural and other social activities by awareness programmes, Adult Education Classes, Lectures, Essay Competitions, Symposiums, Cultural Programmes, Press Conferences and Seminars.

(i) To purchase/acquire the land and/or the building in the name of the Trust and make construction thereupon.

(j) To establish, maintain and run studentship, scholarships and render other kind of aid to students including supply of books, stipends, medals and other incentives to study, without any distinction as to caste, colour, race, creed or sex.

(k) To promote, establish, support, maintain or grant aid to institution for the promotion of science, literature, music, drama and fine arts, for the preservation of historical monuments and for the research and other institutions, in India, having similar objects for the benefit of the public in general.

(l) To establish, maintain or grant aid for the establishment and/or maintenance of parks, gardens, gymnasiums, sports clubs, dharamsalas and rest house for use by public in general.

(m) To establish, maintain or grant aid to homes for the aged, orphanages or other establishments for the relief and help of the poor, needy and destitute people, orphans, widows and aged persons.

(n) To establish and develop institutions for the physically handicapped and disabled or mentally retarded persons and to provide them education, food, clothing or other help.

(o) To grant relief and assistance to the needy victims during natural calamities such as famine, earthquake, flood, fire, pestilence, etc. and to give donations and other assistance to institutions, establishments or persons engaged in such relief work.

(p) ~~to grant aid or render assistance to other public charitable Trust or institutions.~~

(q) To do such other things/acts/activities which are necessary and which may be incidental or conducive to the attainment of the objects of the Trust.

Without prejudice to the generality of the above objects and for effectively carrying out the same the Trustee(s) shall have full right to receive, hold and possess any property including securities of any kind and to construct and maintain any building, to manage transfer or otherwise dispose of or deal in any property of the Trust and to enter into any contract for or in connection with the purposes of the Trust to raise moneys and funds for the benefit of the employees of the Trust and to accept the management of any other trust or endowment in which this Trust may be interested. The Trustee(s) shall have also the right to frame rules and byelaws under its constitution.

4. The Founder shall also be one of the Trustees. The Founder and the first Trustee during their lifetimes may nominate Co-Trustee(s) by the majority of the Trustee members.

5. If any of the Trustees becomes bankrupt or found guilty of an offence involving moral turpitude or become insolvent or resigns from his post or otherwise incapacitated physically,

accumulations thereto, to any one or more of the objects of the trust, as the trustees may, in their discretion, deem fit from time to time.

(c) To convert and deal with the trust property and/or any investments for the time being.

(d) To ~~invest the Trust Fund~~ either in the purpose of mortgage of immovable property or in shares, stock or debentures or other securities and investments, or in deposits with or loans to any company, bank, firm or any other person, and to alter, vary or transpose such investments, from time to time at the discretion of the trustees.

(e) To borrow or raise or secure payments of moneys and also to lend money either with or without security.

(f) To sell, dispose off, alienate or otherwise deal with any property comprising the Trust Fund.

(g) To let out, demise any immovable property comprised in the Trust Fund for such period and at such rent on such terms and conditions as the trustees in their discretion may think fit.

(h) To open account in the name of the Trust, Trustees and/or Institutions run/ conducted by the Trust with a Bank or Banks, to operate such account and to give such instruction to the Bank and to provide for opening and operation of such account by one or more of the Trustees or by an agent engaged by the Trustees.

(i) To adjust, settle, compromise, compound, refer to arbitration, all actions, suits, claims, demands and proceedings regarding the Trust Fund.

(j) To engage constituted attorneys or agents and to delegate to such attorneys or agents all or any of the right vested on them under these presents and from time to time remove such attorneys or agents and to engage other or others in his or their place.

(k) To engage or make provision for the engagement of any person (including all or any of the trustees and committees or administrator or Managing Trustees or otherwise) for the purpose of the administration of the Trust in such manner and at such terms and conditions subject to such rules and regulations as the Trustees may prescribe and also to engage or provide for the engagement of separate Trustees to hold any fund or investment subject to the provisions of this Deed in such manner and subject to such rules and regulations as the Trustees may from time to time think fit.

(m) To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and/or running any institution in furtherance of the objects of the Trust and otherwise for giving effect to the objects of the Trust.

conditions to any subscription or donation made by them.

(o) To set apart and/or allocate the whole or a part of the income or the corpus of the Trust Fund or part thereof for any of the objects of the Trust.

(p) To join, cooperate or amalgamate this trust with other or others having kindred or allied objects, upon such terms and conditions as the Trustees may in their discretion think fit, particularly having regard to and in conformity with the objects and nature of this Trust.

(q) To give aid by way of donations out of the income or the corpus of the Trust Fund or otherwise, to different charitable institutions, societies, organizations or Trusts in India which may have been established or which may hereafter be established for the like charitable purposes mentioned in these presents or any of them to enable such institution, societies, organization or Trust to start, maintain or carry out such charitable objects.

(r) To settle all accounts and to compromise, compound, abandon, or refer to arbitration any action or proceedings or disputes, claim, demand or things, as deemed proper for such purpose without being responsible for any loss occasioned thereby.

(s) To borrow moneys either on the security of any property comprised in the Trust Fund or otherwise for all or any of the purposes of these presents, and it shall be lawful for the Trustees to make such borrowings on payment of such interest and otherwise on such terms and conditions as they may in their absolute discretion think fit.

(t) To apply to the Government, public bodies, urban, local, municipal, district and other bodies, corporation, companies or persons for and to accept grant of money and of aid, donations, gifts, subscriptions and other assistance with a view to promoting the objects of the Trust and to discuss and negotiate with the Government Department, public and other bodies corporations, companies or persons, scheme and other work and matters within the objects of the Trust and to conform to any proper condition upon which such grants and other payments may be made.

(u) To take over or amalgamate with any other charitable trust, society, association, or institution with similar objects.

(v) To establish, promote, manage, organise or maintain or to assist in establishing, promoting, managing, organising or maintaining any branch of the Trust or any other Trust or its branches with objects similar to those of this Trust and to promote or carry on the affiliation or amalgamation of such other Trust with this Trust.

(w) To take over, acquire, manage, control or aid any existing institution or institutions having objects either wholly or in part similar to the objects of this Trust and on such terms and conditions as may be thought expedient.

(x) To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any or more of the Trust, Societies, Institutions or Associations with which this Trust is authorised to amalgamate.

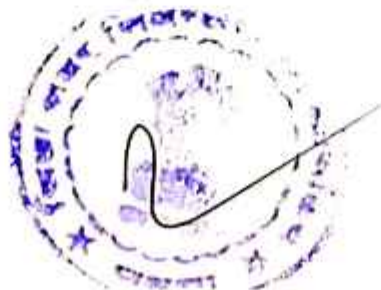

(z) To transfer and hand over the Trust to any other Society, Corporation, Institution, Trust or Organisation on such terms and conditions as the Trustees shall in their absolute discretion think fit and proper to be held by the Society, Corporation, Institution, Trust or Organisation with the powers, provisions, agreements and declarations, appearing and contained in these presents subject to such transfer modifications as may be necessary and consequent to such transfer of the Trust Fund. The trustees for the time being of these presents shall become discharged from the Trust hereof relating to Trust Funds so transferred.

13. The Trustees shall be accountable only for such moneys, stocks, shares and funds as shall actually come into their hands and a Trustee shall not be answerable or accountable for neglect, default, acts or omission or commission of the other Trustees, nor of any banker or other person with whom the Trust properties or any securities may have been deposited or kept.

14. The Trustees may reimburse themselves all expenses actually incurred by them in connection with the Trust or their duties relating thereto.

15. The number of the Trustees shall not be less than two including the Founder. If the number of the Trustees shall fall below two, the trustees shall not, except for the purposes of filling any vacancy, act so long number is below the said minimum.

16. The Managing Trustees for the time being will be at liberty to make/induct additional Trustee within the number mentioned above for such period or on such terms as to retirement and re-induction as the Trustees for the time being consider proper. A person shall cease to be a Trustee either: (i) if he without leave of absence does not attend three consecutive meetings of the Trustees or for one calendar year, whichever is longer, or (ii) if he is requested to resign by 3/4 th or as near thereto as possible of the remaining Trustees.

17. Every Trustee shall be at liberty to resign on giving one month's notice of his intention to do so.

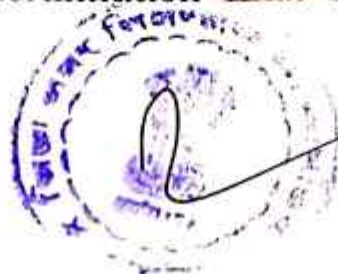
18. The Trustees may from time to time frame rules for the conduct and regulations of the meetings of the Trustees. In the absence of such regulations:-

20. The accounting year of the Trust shall be the financial year ending on 31st March every year.

21. The Trust and the Trust Fund shall be and irrevocable for all times.

22. The office of the Trust shall be situated at Patna unless changed by the Trustees by 2/3rd majority.

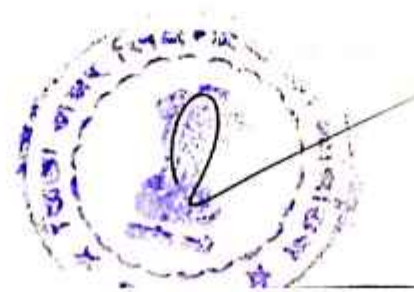
23. It is expressly declared that no part of the Trust property or its income or any accretion thereto shall be applied for any purpose outside India or for any purpose which is not a charitable purpose in law, and all provisions hereof shall be construed accordingly.

24. That in the event of dissolution of the trust the trust property, after meeting all liabilities shall be given or transferred to some other institution engaged in medical education to the children, research or treatment of all diseases and similarly functioning without profit or to the Govt.

25. If for any reason, this Trust shall fail, the Trust properties and funds shall devolve upon the Trustees at the time of failure of the trust and they shall transfer the properties & funds to any other trust having similar objects and satisfying the conditions laid down in section 80-G 68 the Income Tax Act, 1961 if a resolution of that effect is passed by the Trustees unanimously.
